The Marias River Livestock Association board of directors met on Monday, September 10th at the Marias Valley Golf Course Clubhouse at 6 p.m. Attending the meeting was: Dean Lerum, Bob Thompson, Diana Thompson, Boo Boo Bird, Chris Kimmet, Jeff Habets and Carrie Lerum.

President, Dean Lerum called the meeting to order. Bob moved and Jeff seconded to approve the minutes as read. Motion carried. Bob moved and Chris seconded to approve the Treasurer's Report. Motion carried. Carrie passed around thank you notes received from our youth contest winners.

Bob reported on the Predator control meeting in Liberty County. Turns out that they didn't have a pilot to fly, but now they have the position filled. They also needed more money to implement the program and it was voted 6 to 5 to increase the assessment fee.
